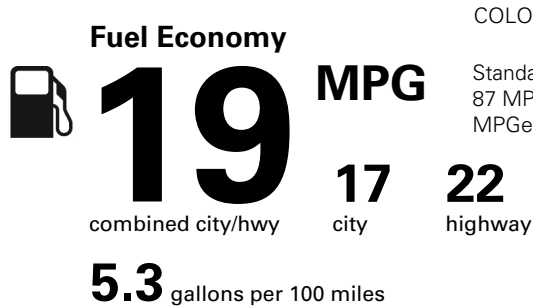

Gasoline Vehicle

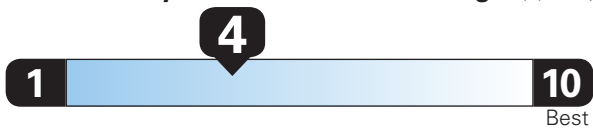

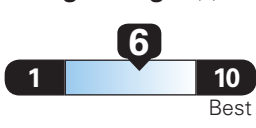
